This award recognizes district teams who have been able to break their organizational silos to work toward a common goal to improve student achievement. The award, *Making Strides Together*, will be presented during our upcoming Annual Academic, Information Technology & Research Conference, July 11-14, 2016.

The *Making Strides Together* award allows us to recognize a district that is strategically involved in cross-functional teaming for planning, implementing, and monitoring progress on a regular basis. In order to be eligible for this award, district teams should organize documentation according to the award criteria listed below:

- Process used to determine the focus of the initiatives
- Development of a shared vision
- District team's timeline in planning, implementing, progress monitoring and evaluating the initiative
- Adjustments made to improve the initiative based on feedback loops, satisfaction surveys, observations, or other data
- Communication across departments and at the school level
- Systematic use of human resources to support the initiative
- Evidence of impact on student achievement

Making Strides Together Award for Excellence in Urban Education

ELIGIBILITY REQUIREMENTS DISTRICT TEAMS

- The district must be an active member of the Council of the Great City Schools.
- Nominees must be willing to attend the Annual Academic, Information Technology & Research Conference to accept the award on Tuesday, July 12, 2016. Registration is waived for district team winners.
- Employees, retirees or relatives of employees or retirees of Curriculum Associates are not eligible for the award.
- Neither the members constituting the Board of Judges nor their relatives are eligible to be nominated. (The Council of the Great City Schools will select the Board of Judges.)

NOMINATING PROCEDURE

- Each year, the Board of Judges will select one district team winner from applications **submitted by email or hard-copy** to the Council of the Great City Schools.
- Nominations sent directly to Curriculum Associates will not be considered.
- Completed applications must be received by June 7, 2016.

JUDGING CRITERIA

The district team award winner receives the highest rating based on evidence submitted according to the application criteria.

The Making Strides Together Award will be awarded without regard to race, creed, religion, sex, age, or national affiliation.

Applications must be received by the Council of the Great City Schools no later than June 7, 2016. The winner will be notified by the Council of the Great City Schools.
