**ADDITIONAL QUALIFICATIONS**

**REQUIRED:** Demonstrated workforce management principles, strong written, verbal and interpersonal skills. Experience working with multiple internal and external stakeholders.

**SUPERVISION:**

This position supervises all employees assigned to the Division of Human Resources & Equity.

**POSITION GOAL:**

To enhance the success of the Broward County School Board in the deliverance of superior education to students by providing substantial and effective leadership direction and oversight of the Human Resources & Equity Division and for attracting, developing, retaining and promoting staff recruitment and equity of a qualified workforce comprised of instructional and non-instructional employees, and by creating a positive and productive work environment and relationship with the community, business and governmental stakeholders.

**ESSENTIAL PERFORMANCE RESPONSIBILITIES:**

**The Chief Human Resources & Equity Officer shall carry out the performance responsibilities listed below.**

Oversee the strategic planning, design, and management of programs, policies, and procedures designed to create a positive work environment by:

1. Collaborating with the Labor Relations team to bargain collectively and to bargain the impact of decisions in good faith with employee representatives while adhering to federal and state employment labor relations laws and regulations. This includes the provisions within all collective bargaining agreements and employee benefits; including health care and all other insurance benefits. Overseeing strategic management and planning of employee life cycle functions across the Division of Human Resources & Equity including, but not limited to, recruitment and selection, onboarding, employee and labor relations, EEO/ADA requests, compensation and HRIS services, employment services and benefits, and unemployment administration. Managing activities governing the recruitment, selection, and employment of instructional and non-instructional employees.

2. Leading short- and long-term projects related to Human Resources & Equity strategic initiatives that align with the District's Strategic Plan.
3. Ensuring the maintenance of a competitive compensation structure for the workforce throughout the District.
4. Chairing the Superintendent's Insurance Advisory Committee to monitor, evaluate, and recommend employee health care plan changes, such as wellness program initiatives, retirement, savings, and other employee benefits.
5. Performing and promoting all activities in compliance with equal employment and non-discrimination policies of The School Board of Broward County.
6. Participating successfully in training programs offered throughout the District to develop and increase individual skill levels and proficiency related to assignments.
7. Reviewing current developments, literature and technical sources of information related to job responsibilities.
8. Ensuring adherence to safety rules and procedures.
9. Following federal and state laws, as well as School Board policies.
10. Performing other duties as assigned by the Superintendent of Schools or designee.

**SIGNIFICANT CONTACTS –frequency, contact, purpose, and desired end result:**

Frequently has contact with the Superintendent, School Board members, union officials, employees at all levels, the community, professional organizations, and governmental officials. The purpose of these interactions is to develop and implement sound policies and programs, obtain input, resolve problems, and remain in compliance with legal statutes.

**PHYSICAL REQUIREMENTS:**
